***Jack Kalkman** met with the cardiac/thoracic surgeon on Wednesday, February 8. He completed an extensive round of testing February 13-17; doctors will now meet to discuss their surgery plans. Surgery on the ascending aorta may occur during the last week of February; surgery on the descending aorta would take place 4-6 weeks following.

***Jean Wynsma** will meet with the doctor on February 22 to determine when to begin radiation treatments--and to determine their duration.

***Emily Lopez** is currently in the final trimester of a very difficult pregnancy. As a result of the pregnancy, she has been experiencing constant sickness--as well as an excessively rapid heartbeat. Additionally, the rapid heartbeat has caused a spike in her earlier diagnosis of pulmonary stenosis. Emily underwent an EKG on February 6; the results are pending. A growth ultrasound of the baby took place on February 9.

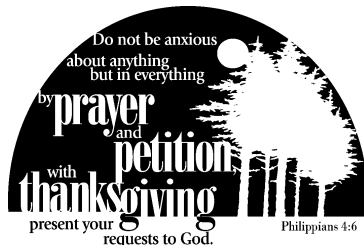
